You may want to see our community be the healthiest we can be and know that having healthy pregnancies and babies are the cornerstones to a healthy community.

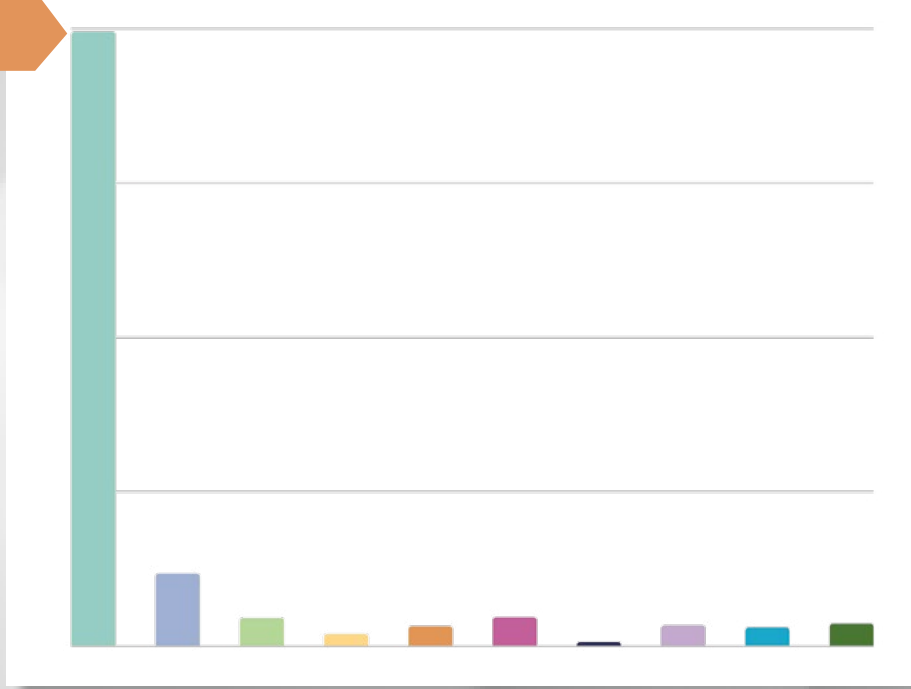

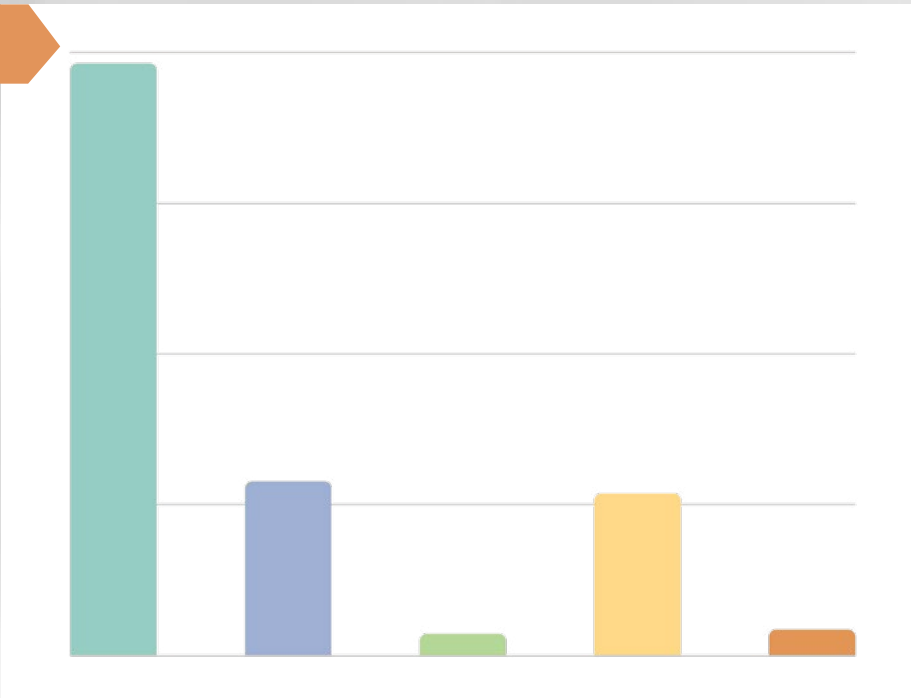

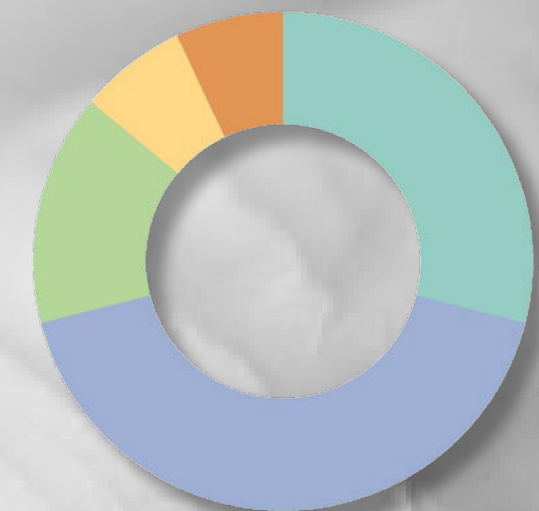
